TENDER NOTICE

Sealed tenders on the basis of Single Stage Two Envelopes Procedure are invited from well reputed firms registered with Pakistan Engineering Council (PEC) in relevant category for the current Fiscal Year.

The interested bidders will have to deposit Tender Fee (non-refundable) along with formal application for issuance of Tender Documents.

The bid will be comprised of two sealed envelopes. First envelope will contain Technical Bid and other Financial Bid. Technical Bids will be opened first by notified Tender Opening Committee in presence of respective bidders while Financial Bids will remain **Unopened**. Technical Bids will only be checked and announced as 'Responsive / Non-Responsive. After this evaluation, the tender committee will proceed to open Financial Bids of only responsive bidders. The Technical Bids of Non-Responsive Bidders will be returned **Unopened**.

The following documents will be required in Technical Bid for evaluation as responsive:-

- 1- Copy of Valid License of Pakistan Engineering Council in relevant category.
- 2- Copy of registration certificate of Federal Board of Revenue.
- 3- Copy of registration certificate of Punjab Revenue Authority.
- 4- Copy of Paid Professional Tax.
- 5- Affidavit on Stamp Paper of Rs 150/- about Non-Blacklisting and No Litigation with any Government Dept., Semi Government Dept. and Autonomous Authority.
- 6- Copy of registration certificate of Registrar of Firms / Securities & Exchange Commission of Pakistan (where applicable).
- 7- Copy of Partnership Deed (where applicable).
- 8- Copy of Bank Statement of Firm of last Three Months.
- 9- Name, Qualification, Experience and Designation of Management of Firm.
- 10- Name, Qualification, Experience of Engineers and Technical Staff employed by Firm.
- 11- Brief Details of Completed projects of similar nature in last Three years with Work Orders and Completion Certificates.
- 12- Brief Details of In-Hand projects of similar nature with Work Orders.

Conditions

1. Tender fee and bid security will be in the form of CDR/Bank Draft in the favour of Treasurer GCWUF.
2. Conditional or without Bid Security, tenders will not be entertained.
3. The Procuring Agency may reject all bids or proposals at any time prior to the acceptance to the bids or proposals as per PPRA Rules. The Procuring Agency shall, upon request, communicate to any supplier or contractors who submitted bid or proposal the grounds for its rejections, but is not mandatory to justify.
4. Tenders received after due date and time will not be accepted.
5. Original CDR will be placed with Technical Bid.
6. Tenders will be received in the office of the undersigned at 11.00 AM and will be opened on the same day at 11.30 AM by the Tender Opening Committee in presence of intending bidders or their representatives.
